## **Publication of voting rights pursuant to sec. 26 WpHG (German Securities Trading Act)**

HUGO BOSS AG received the following notification pursuant to sec. 21 para. 1 WpHG on May 12, 2015:

### **1. Notification of BlackRock International Holdings, Inc. Wilmington, DE, USA**

BlackRock International Holdings, Inc. Wilmington, DE, USA, has notified us that its percentage of voting rights in HUGO BOSS AG, Metzingen, Germany, falling below the threshold of 3% on May 08, 2015 and amounts to 2.90% (equals: 2,043,204 voting rights) as per this date. Of these voting rights 1.16% (equals: 813,936 voting rights) are to be attributed to BlackRock International Holdings, Inc. Wilmington, DE, USA, pursuant to section 22 para. 1 sentence 1 no. 1 WpHG; 0.004% (equals: 2,900 voting rights) are to be attributed pursuant to section 22 para. 1 sentence 1 no. 2 in connection with sentence 2 WpHG; 2.01% (equals: 1,418,338 voting rights) are to be attributed pursuant to section 22 para. 1 sentence 1 no. 6 in connection with sentence 2 WpHG.
